### 1. OPEN FORUM

- (a) **Soccer Season** (Brian Norton – Glenmore Street) – Northbridge Soccer Club successful with 3 teams winning their grades. Grand Final will be Sunday 21<sup>st</sup> Sept at Bicentennial Reserve commencing at 9am.
- (b) **School for Naremburn** (Brian Norton) – stated that credit should be given to Clr Barry Thompson for initially raising the issue of a school Naremburn, which he did in November 2007.
- (c) **St Cuthbert's Church** (Roger Promnitz – Merrenburn Ave) – Services have ceased at St Cuthbert's Church; now conducted at St Leonard's Catholic Church Hall with Kid's Church in the upstairs studios; the Naremburn Cammeray Anglican Church is grateful to the Catholic Parish for use of its facilities; commencement of work has been delayed pending builder's letter of intent.

## **8. FEDERATION OF WILLOUGHBY PROGRESS ASSOCIATIONS AND WARD COUNCILLORS' REPORT**

### **Ward Councillors**

**Councillor Barry Thompson** – Last Council Meeting, prior to the Elections on 13 September, has been held; things are quiet. Cllr Thompson commented that in the current election campaign that there had been a lot of misinformation published and distributed about both the Civic Place project and the threat of rate increases. He suggested that residents compare rate notices for this year with those of next year.

### **Federation**

**Kevin FitzPatrick** and Don Swonnell attended Meeting on 30<sup>th</sup> July. Issues discussed included the abuse of Disabled parking areas; commuter parking in Naremburn area that prevents residents having access to parking adjacent to their homes. Parking at Shore Oval - Shore's governing body took WCC to the Land and Environment Court regarding parking, the hearing is 23<sup>rd</sup> Sept on site. The Walter Burley Griffin Incinerator will cost WCC in excess of \$1 million after State and Federal grants; objection to the installation of a lift due to visual impact; replacing the chimney stack could escalate costs although use of less substantial materials could be a solution. Incinerator opening is planned for March 2009 and the Café towards the end of 2009. The Northside Garden Fair, sponsored by the Northbridge Rotary Club, will be held in Bicentennial Reserve on 28<sup>th</sup> Sept 2008. ABC will be broadcasting live from site. The Federation has invited all Progress Associations to use its stall to promote the Progress Associations. Don and Kevin have stated that they will be involved but have asked for more volunteers. Next Federation Meeting will be 18<sup>th</sup> October.

**(b) Events** – Community Centre Open Day will be held on Saturday 20<sup>th</sup> Sept. from 10am – 2pm. WSO will be performing at Naremburn Park again next year.

**(c) Library and Community Centre** – The situation regarding the proposed changes to the Community Centre was discussed by phone with Marcia Waller on 11/09/2008. Preparation of the Naremburn Community Centre master plan has been delayed because of the time taken to complete the development application for relocating the Out of School Hours (OOSH) centre to the Bales Park building. The consultation and planning process for the changes to the Community Centre including the library and meeting rooms will occur when the OOSH work is being undertaken at Bales Park.

**(d) Membership** – The NPA now has 100 financial members. 32 new members this year. 20 members not on email and these members receive photocopies of all Minutes hand delivered to their street mailboxes.

**(e) Naremburn Matters** – September issue has been circulated; Editorial Committee ensured that each group standing for election as Councillors for Naremburn Ward provided a 100 word statement from the group leader and a headshot; candidates for the Mayoral election had the same offer; there was a nil response from the third candidate so Mayor Cllr Pat Reilly and Cllr Stuart Coppock were given a very short deadline for 200 words – however they were pleased to comply. There was a problem with one advertiser submitting an ad in an Apple format that was not able to be opened by our publisher; the advertised met our publishing deadline by minutes (the Editorial Committee had a backup advertisement lined up if needed).

**(f) Open Spaces and Landscaping** – the problem of dogs off leashes at Bicentennial Reserve was raised. Don Swonnell reported that fox baits have been laid in the Area.

**(g) Young Parents Group** – The August working party meeting and Public Meeting of August 27<sup>th</sup> were postponed by Council and new dates will be set after the Council elections. The working party meeting is likely to be held in the first weeks of October. Currently the Council's consultant is undertaking a review of the schools in the Willoughby area, and by the meeting they will hopefully be able to table the report. There should also be some progress to report about the consultation between DET and the Catholic Education Office. At the beginning of August there was a short article in the North Shore Times regarding the school issue. The application for a pre-school at the Brook St end of Donnelly St has been resubmitted. There are concerns that the traffic access to site would not be safe. However, it is also recognized that there is a great need for childcare in the Naremburn.
