'School' Public Meeting Draws Large Crowd

Despite the severe electrical storm on Wednesday evening 29 May, more than 150 residents attended the meeting called by WCC to discuss 'Naremburn Public School – Options for the Future'. Our Public School was closed in 1990 and the Catholic Primary School closed in 1996. Since that time, the number of children in our suburb has increased dramatically.

The meeting, chaired by WCC Mayor Pat Reilly, had a panel that included Gladys Berejiklian, Member for Willoughby, Deonne Smith, Regional Director, Northern Sydney Region, Department of Education and Training, Brother Tony Whelan, Catholic Schools Office, Broken Bay Diocese. From WCC, General Manager Nick Tobin, Community Services Director Marcia Waller, Environmental Services Director Greg Woodhams were also present. St Leonards Catholic Church provided its Parish Hall for the meeting, a much appreciated gesture given that there is no other public venue in Naremburn large enough to hold such a gathering of residents. Brief position statements from panel members were followed by a Q & A session of at least one hour, during which several residents were able to comment and ask questions.

Naming the un-named lanes of Willoughby City John Allen Lane, Naremburn

WCC recently proposed that 65 un-named lanes in Willoughby City, lanes marked with a 'W' and a number, be given names. For Naremburn this involved 16 lanes; a list of proposed names selected by the Willoughby Historical Society, and Council was released. Most of the names chosen for lanes in our suburb honoured members of the NPA from its inception in 1901. Both this Progress Association and the Federation of Willoughby Progress Associations (FWPA) submitted to Council, that one of the Naremburn lanes be 'John Allen Lane' to honour the former resident of Olympia Road, who was not only active in the NPA, but was also President of the Federation (all 9 progress associations in Willoughby City) from 1995 until his death in September 2007. John made an invaluable contribution to Naremburn and the City of Willoughby. W85 will be 'John Allen Lane'.

President – out and about

This may be our winter edition of Nareburn Matters but things are hotting up in the 'burn!

- The NPA's newest Sub-Committee, Young Parents (name under construction), Karen Pearson, Belinda Lewis, Brian Norton, Chris Chaseling and me, made a valuable contribution to our highly successful public meeting on a school for Nareburn. Karen and Belinda collected signatures on a petition regarding a K-2 primary school and presented that petition to Council on 14 April.
- The Flat Rock Creek Bridge, at Nareburn's northern border on Willoughby Road is undergoing a facelift. Its degraded condition was first raised by the NPA, and our thanks to our local Member, Gladys Berejiklian, for her persistent follow through with the Minister for Roads, over a period of 18 months.
- Following on from our representations to WCC, Council is enhancing the east side of Willoughby Road between Garland Road and Slade Street with the planting of 16 *Eucalypts* and 1200 *Lomandra tanika*. Thank you WCC for a cleaner, greener, gateway to Nareburn.
- The NPA supports the *Keep it Local* campaign and we did endorse the letter sent to the Premier and the Minister for Planning by the Federation of Willoughby Progress Associations, opposing the State Government's proposed pro-developer laws. See www.keepitlocal.org.au for more information.
- The NPA is engaged in the community consultation process for DAs and very specifically the DA lodged by the North Sydney Leagues Baseball Club for the installation of 25 metre high light towers to illuminate the baseball diamond in Bicentennial Reserve close to Flat Rock Drive.
- Our website is under construction and we are grateful to NPA members Nigel Smith and Rebecca Lazenby for both their professional expertise and their time freely given to help the NPA keep its community informed.
- The Willoughby Symphony Orchestra free concert in Nareburn Park on Sunday 16 March was a great success and we thank our Events Sub-Committee members for putting the proposal for this event to Council and for the time they spent working with WCC's Performing Arts.
- At this concert, the Willoughby Symphony Choir approached the NPA about staging a Christmas Carols event in Nareburn; negotiations are underway.

We appreciate your support and thank those many residents who have become new members of the NPA thus far, this year. We also thank our loyal supporters, our members of long-standing who are always prepared to lend a helping hand. Resolutions Passed at the Public Meeting on 28 May, at St Leonard's Catholic Church Parish Hall on 'Nareburn Primary School – Options for the Future.'

1. That having regard to the changes in demography of the Nareburn area, the Department of Education, Catholic Diocese of Broken Bay, local Member for Willoughby and Willoughby City Council commit to work together to achieve the opening of a new school within two years in Nareburn.
2. That the representatives from the Department of Education and Training and the Catholic Diocese, Broken Bay be thanked and efforts noted and appreciated for their mutual collaboration on this issue.
3. That we immediately establish a Nareburn Precinct School Working Party, such working party to be facilitated through Willoughby City Council.
4. The State Member, with our Council and community support, seeks delegations to meet with the Minister for Education and Minister for Transport to put forward the community concerns.
5. That we seek support from North Sydney Council on this issue.
6. That a further Public Meeting be reconvened in 3 months to report on progress.

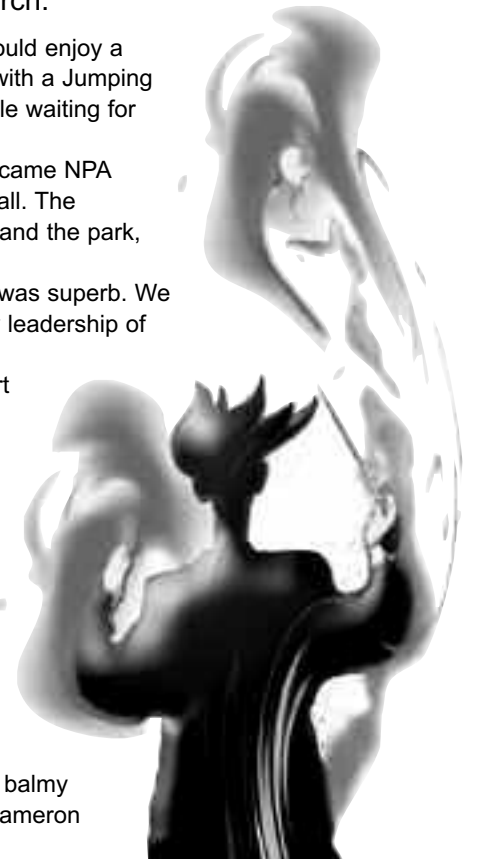
We peopled our NPA stall from 1:00 pm until 8:00 pm and welcomed the residents who became NPA members on the day. During part of the evening Mayoress Beth Reilly sat with us at the stall. The Mayor came to visit, as did Cllr Thompson. Gladys Berejiklian paid a flying visit to our stall and the park, in between two engagements.

The pre concert entertainment included the Willoughby City Band. The symphony concert was superb. We were treated to the brilliant playing of violinist Cameron Hill, and the enthusiastic and lively leadership of world-renowned chief conductor, Nicholas Milton. In their speeches, both the Mayor and Nicholas mentioned the Naremburn Progress Association's initiative in requesting a concert in our park.

WCC's Performing Arts Manager, Tim Long, together with his team did an excellent job in what was for them their largest outdoor event. We appreciated the cooperation and assistance of Allan Rendell and Cameron Kennedy. Allan said that over 800 people had attended the concert. It was great to see so many residents relaxing on their rugs, sipping wine and enjoying a picnic. Food stalls did reasonable trade but most of the locals brought their own tucker.

On the night several business people expressed interest in sponsoring the event. Our goal is for a concert in Naremburn Park to be an annual event. Council did foot the bill for this concert – our thanks to the Mayor and the Councillors. The value of this event is immeasurable. Practicalities are that a WSO concert ticket is \$35 for single performances, and there are subscription series of 4, 5 or 6 concerts.

As one NPA member said in his thank you email: "We have just returned from a wonderful balmy evening under the stars in Naremburn Park seeing and hearing the wonderful WSO and Cameron Hill; \$5 for a Rogan Josh and all that wonderful music – what a bargain!"

Excerpt from her 'Private Member's Statement' delivered in Parliament, 28 February 2008, 5.50pm

Willoughby Electorate Planning

I convey the view of my electorate and raise community concerns regarding a discussion paper issued by the Minister for Planning entitled, "Improving the New South Wales Planning System".

Many local organisations and concerned residents have forwarded copies of their submissions to the Minister and the State Government about the proposals. In summary, their submissions highlight that the current proposals in the discussion paper remove and diminish communities' participation in decisions that affect them.

They are concerned that the proposals remove development decisions from our elected local government representatives and place those decisions in the hands of private certifiers paid by development proponents. Another concern is that the proposals will result in approved development in residential areas without any reference or notification to the community or adequate consultation with affected neighbours. I know many Willoughby residents feel strongly about that. We are blessed to have wonderful surroundings and many residents have worked hard during their lifetime to be able to live in the Willoughby electorate. Many are concerned about the impact of the proposals on their quality of life and on the environment.

Other concerns raised by community organisations in their submissions to the Minister include that the proposals will not provide for the proper assessment or protection of environmental features. The discussion paper does not include any relevant information about the way in which particular and special character, quality and features of local areas including conservation areas and items with significant natural and cultural heritage values will be identified and protected from degradation.

Throughout the electorate of Willoughby there are pockets of areas that are of significant cultural heritage, not just to the electorate of Willoughby but also to the State at large. Clearly, this is a major concern to many progress associations and other community groups that have contacted me about this matter. There is a concern about the overall effect of the proposed changes on the relationship between developers and developments. People feel that the current proposals will not enhance transparency but will cause there to be greater levels of dishonesty in local planning issues. Those types of issues have been raised directly with me by many organisations. Organisations have lost confidence in the process, given the short period allowed by the Minister for consultation.

I am sure many organisations across New South Wales have spent a considerable time putting together their submissions, but many believe the length of time available to them is not sufficient. Many organisations that have contacted me said that they were in favour of the direction that the Local Government and Shires Associations were going in their approach to this issue. I again place on record that the future of our local communities is important to all of us. Residents and community organisations in the Willoughby electorate certainly feel strongly about this. I urge the Minister for Planning, Frank Sartor, to take all those submissions into consideration and to ensure that the quality of life in our communities is not irrevocably destroyed.

Council Elections

Election Day for WCC is Saturday, 13 September. Our March issue featured all three Naremburn Ward Councillors. This issue has articles by the Member for North Sydney and by the Member for Willoughby. In our September issue we will allocate space for each of the candidates for election for Naremburn Ward, as well as candidates for Willoughby Mayor.

Naremburn Survey

HomeTraders Real Estate recently commenced a survey of Naremburn residents to see what the people in the community valued or had concerns about. Below are the findings so far.

■ Factors leading people to the area. Most agreed that key factors are:

1. Proximity to the city and the station.
2. Diverse and quaint housing.
3. An interesting population mix.

■ When asked about some genuine concerns, responses included:

1. The lack of a local primary school was a real concern among young families.
2. Parking and traffic issues: Traffic flow, particularly on Waters Road and Dalleys Road, mainly a problem at peak times. Those living close to St Leonards were fed up with trying to park. Despite much of the area having residents' parking, this is still not adequate.
3. Those living close to St Leonards Station found security a concern, both personal safety and belongings.
4. Street lighting, particularly on Francis Street and the path to St Leonards.

Liz Price and Matt Johnson will continue to knock on doors to gain some insight into the community so please support them. We look forward to the final results.

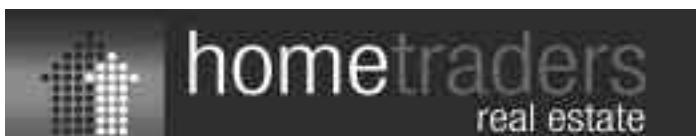

Naremburn's Bushy Bits

In this issue, we travel along Bicentennial pathway, beside what one-time resident Henry Lawson described as “the scrub ridged western side” of Flat Rock Gully. Before we do, did you know that the area between the ends of Market Street and Garland Road was a proposed site for Burley Griffin's Incinerator, with entry from Brook Street? One wonders what the future of the gully might have been.

Let's begin under Flat Rock Drive; a tunnel to connect Bicentennial with the new Flat Rock Gully Reserve was installed. Inside, a beautiful mural depicting local flora and fauna was painted, in 1998, by Aboriginal artist, Carl Simpson, ably assisted with hand stencils by children from the Trumper Pavilion Vacation Centre in Chatswood.

As we continue on with the ridge top on our left, all to our right is buried rubbish and fill once known as the 'Naremburn Tip'. The gully beneath us sloped down 30 metres to Flat Rock Creek that now runs in a box culvert about a metre beneath the pathway.

All along this ridge, market garden rock terracing is still very much in evidence. Eventually covered in huge weeds, privets and other exotic garden escapes, in 1996-97, the Flat Rock Gully Bush Regeneration Team began extensive regeneration, re-vegetation, and careful habitat restoration assisted by corporate and community planting teams. The Bicentennial Bushcare Team and contractors now maintain it.

A little further along an original bush remnant was discovered revealing changes in vegetation, particularly trees, including *Eucalyptus haemastoma* (Scribbly Gum), *Elaeocarpus reticulatus* (Blueberry Ash) and *Allocasuarina littoralis* (Black Sheoak), all valuable information for re-vegetation.

Moving on we come to an old concrete 'drop pit', transformed by Aboriginal artist and sculptor, Shane Haurama in 2007, to depict the past, present and future of the indigenous people and the gully landscape.

Now the rocky ridge becomes more evident; we come to what is now known as Henry Lawson's Cave, a place where the great man 'rested', between bouts of spirited behaviour at local pubs, as well as being a nice place to contemplate the gully, the roar of the nearby waterfall, and the creek running below.

Earlier I mentioned habitat restoration, because, in sections along this ridge, a critter was discovered, thus far unique only to Naremburn within Willoughby City – Burton's Legless Lizard, last seen, perhaps appropriately, at Henry's Cave. Other local residents include a pair of white-faced Herons and a Pacific Baza, with the pathway corridor being used as a nesting and hunting area by Butcher Birds and Tawny Frogmouths.

Now, up to Gaza Road we find a huge block of sandstone, very hard, called ironstone, carved by Ishi Buki sculptors, depicting patterns from the Incinerator. Behind this, buried under the Leisure Centre's car park, lies the huge flat rock ledge, thought to be the inspiration of the Gully's name. Behind that, up on Small Street is Burley Griffin's Incinerator, the source of all the problems. Not able to cope with early to mid twentieth century rubbish, it was decided to tip and fire up the rubbish into the Gully, with a box culvert going straight under Flat Rock Creek Bridge, causing the destruction and burial of the beautiful Naremburn waterfall. Its position is shown by a photo plate on a pole alongside the pathway above; a series of photo plates on poles along the pathway from the bridge and Henry's Cave, give an interesting picture of what was.

And so we come to Flat Rock Creek Bridge at Willoughby Road. Erected in 1886, opened by Mayor H Fleming, twice strengthened for increased traffic, after years of neglect and inappropriate repairs, it is, as I write, receiving a much-needed face-lift. Stonemasons are re-pointing, and doing minor repairs to the sandstone as well as cleaning it, revealing the vibrant colours of the sandstone and the unique structure of this wonderful old bridge. I can't wait to see the outcome.

This Bicentennial shared pathway is very popular, particularly on weekends, for walking or cycling. There's always something interesting to see.

Next issue, we continue exploring Naremburn's parks and bushy bits.

Until then, keep planting our special native flora.

Break and Enter

The most popular item for theft these days seems to be GPS navigational equipment from cars, so please be careful with these if you don't want to lose them. We are still having items stolen from garages and undercover parking areas, the most popular items are golf clubs and pushbikes, so make sure yours are engraved with identification or the serial numbers are recorded to help police get them back to you.

Police successes

Police arrested a 50-year-old man in Chatswood for bag theft. Following an ATM photo of a man using a stolen credit card police arrested a chap who was charged with four break-and-enters in the area.

Winter wisdom

This time of year is one where people spend more time at home in front of the heater. Many fires in winter are caused by heating equipment. Here are our top tips on fire safety:

- Don't leave heaters on when you are out if you can avoid it.

- Be careful of items left on top of electric oil filled heaters as they can easily catch alight.
- Take care with children in pyjamas as many are quite flammable and only need to brush against a hot element or ember to catch fire – flannelette may be cotton, but it is often highly flammable.
- Leave keys in doors with deadlocks or unlock the deadlocks when you are inside – the last time you want to lock yourself in is when there is a fire.
- Have an evacuation plan – it sounds very corporate, I know, but what would happen if there was a fire? Would your family know to keep down low and which door/window to use to get out in a hurry?
- If you have a wood burning fire have the chimney cleaned every now and then – chimney fires are bad news.

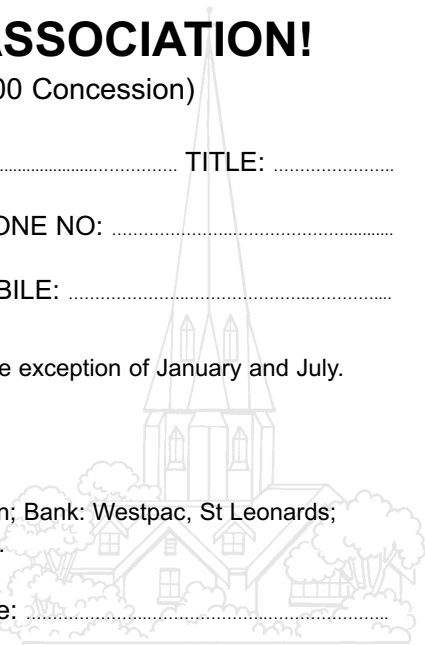

Federal Budget will result in more pressure on Royal North Shore Hospital

In May the new federal government brought down its first Budget. As the Shadow Minister for Health and as the Member for North Sydney, one of my primary interests was to see what the government would do to fix the problems that have been exposed at our own major public hospital – Royal North Shore.

The Prime Minister promised that the ‘buck would stop with him’ when it came to public hospitals so expectations have been running high.

We have all been horrified at some of the stories that have emerged from Royal North Shore. As the parent of young children I perhaps am more acutely aware than ever before about how important it is that we have access to the highest quality public health care. I know that the doctors and nurses at RNSH are some of the best in the world but they have been let down, like many patients, by the system and by a lack of funding from the State government.

At first blush, the federal budget seems to provide some additional money for public hospitals but the devil is always in the detail.

What the government also announced were changes to the Medicare surcharge that will, according to the government’s own figures, drive up to half a million Australians away from private health insurance. It’s a grossly irresponsible policy that shows a lack of understanding about the inter-relationship between the public and private health-care systems.

With so many dropping out of private health insurance, particularly among younger age groups, the inevitable consequence will be higher premiums.

Changing the Medicare surcharge, which has helped encourage so many to insure against ill health, will mean that those 400,000 people will now largely rely on the public system? It will be a catastrophe for public hospitals across Australia as they deal with this exodus from private care and the government has introduced this with no compensation for our hospital system. We have seen estimates that it will cost public hospitals up to \$1.76 billion dollars because of the extra patients they will now have to treat.

At Royal North Shore that will mean longer waiting lists for elective surgery and more pressure on the many out-patient services provided by the hospital. With the hospital already under so much strain it is hard to see how it will cope without additional resources. I will fight against the government’s changes and, if they succeed, I will certainly be putting the case for the additional funding that Royal North Shore and other public hospitals will need to compensate for this very short-sighted policy decision.
