President – out and about

As we come to the end of the year it is timely to reflect on the year's events and activities.

The proposed redevelopment of the Channel 9 site remains an area of concern for both the NPA and the community. At the beginning of March the Planning Assessment Commission (PAC) handed down their decision in favour of the community and Willoughby City Council (WCC); however, Channel 9 has appealed this decision in the Land and Environment Court. Presentations were made to the court by key members of the community and we anxiously await the court's decision. The NPA will endeavour to keep you informed of any decision.

The Naremburn Library and Community Centre underwent refurbishment. The library, while occupying the same space, looks bigger and has a wonderful welcoming feel. The NPA, thanks to the persistent efforts of Kevin Fitzpatrick and Barry Shaw, has a dedicated room for storage of their archives. There are two meeting rooms for hire in the community centre: a large area where we have our general meetings and which is fitted out with the latest in audio visual equipment for the use of those hiring the space plus a smaller room on the right as you access the building.

As the area around the shops has become busier parking restrictions have been changed and are set to change again to ensure fair and equitable access to the shops by all, so check the signs before leaving your car or you may get a nasty surprise on your return!

There have also been changes at WCC initially with the death of our Mayor, Pat Reilly, followed by the election of his successor, Gail Giles-Gidney, and Stuart Coppock as Deputy Mayor. More recently we have heard of the resignation of Nick Tobin, General Manager.

Our sincere thanks go to the many in the community who have supported us this last year notably those who write articles for *Naremburn Matters*, those who distribute them and those businesses who take up advertising space. Without that support we would not be able to continue publishing your newsletter.

Our President, Frances O'Brien, has been called away to the country on family business which has prevented her from writing to you this time; however she hopes to be back in time for the next Naremburn Progress Association (NPA) meeting, which will be the last of the year.

It remains to wish you all a very Merry Christmas and Happy New Year from Frances and all the members of the Naremburn Progress Association Executive.

Have you been naughty or nice?

It's not too many sleeps now until Christmas and not many more until 2015; can you believe that?

Are you planning barbecues over the summer or even hosting Christmas breakfast, lunch or dinner in the garden – weather permitting of course? Have you completed all the projects I have set for you? The water features, hedges, trimming, paths, lawn improvements etc.

I need the answer to that question now — Have you been naughty or nice ... around the house? I hope you're all nice!

By now your plants and lawns will be flourishing with all the warm weather and rain. You've probably begun trimming and tending to them; if not you will soon need to be.

You will also need to start fertilising everything green inside and out — use a complete fertiliser on the garden beds; some plants like azalea, camellias and citrus will benefit from using a specialised fertiliser – have a look around at the nursery and hardware stores bags are usually clearly marked if unsure ask someone in store. When fertilising don't forget the lawns as well as the hanging baskets, potted plants including your indoor plants.

Letter to the editor

I am writing to express my concern about a proposed development at 32 & 34 Northcote Street Naremburn (DA 2014/116).

In 2012 Willoughby City Council created multiple R3 (medium density) zones under the directive of the NSW State Government. The intention of the R3 zone was to increase housing density. The Northcote R3 zone is from Number 32 to 48; the rest of the western side of Northcote Street being zoned R4 (high density) approaching St Leonards station. Two other R3 Zones exist in Naremburn near the corners of Dalleys & Willoughby Roads and Quiamong & Glenmore Streets, allowing building heights up to 9 meters.

The proposal at 32 & 34 Northcote Street consists of a 3 level 15-unit block with 22 car spaces to be built in a residential housing area some distance from St Leonards station.

Willoughby City Council planning officers have recommended approval of the development despite multiple breaches of Development Control Plan (DCP) guidelines such as height, site coverage, setbacks and traffic.

No formal traffic survey has been undertaken. It has been proposed that all traffic from the new development be funnelled into Waters Road over a major storm water drain that is subject to flooding. This end of Waters Road is a narrow cul-de-sac with effectively only one lane of traffic. Over 30 submissions were made from local residents that have largely been ignored.

At the Ward Councillor's meeting in October the residents and developer met to discuss the proposed development. All three Naremburn Ward Councillors unanimously voted to reject the developer's plans, citing the multiple breaches of DCP guidelines and unsuitable traffic access via Waters Road. The matter was then referred to a full council meeting where once again it was suggested to the developer that he should reduce the scale of the development and the matter was unanimously deferred.

However the developer immediately lodged an appeal with the Land and Environment Court with a preliminary hearing scheduled for mid-November. Quite clearly the developer has little regard for community concerns or council DCP guidelines and intends to force a result using legal arguments in court motivated by millions of dollars profit.

The proposal at 32 & 34 Northcote Street will set a precedent for future developments in the newly created R3 (medium density) zones. The State Government appears to be putting unprecedented pressure on local councils to approve multi-storey dwellings with little regard for the local residents or community requirements. Once the current housing bubble fuelled by property investors has reached its predictable end the community and council will be left with the legacy of multiple developments of questionable benefit.


Concerned Naremburn residents should write to their local Ward Councillor to resist inappropriate developments.

Parking issues at Naremburn Shops

Parking at Naremburn shops has become difficult over the last few years. A large proportion of this problem has been caused by motorists utilising the unlimited parking whilst they are at work, as North Sydney Council has reduced the number of unlimited parking spaces in the Crows Nest area.

Willoughby City Council has attempted to alleviate these problems, through changes to parking hours.

The parking at Naremburn shops is a work in progress; there have been some changes to the time limits trialled. Rohan St has been reduced to one hour parking. Dodds Lane has a four hour limit imposed on the south side and Willoughby Road (outside the hardware store) has been reduced to fifteen minutes.

The next proposed round of changes will be to adjust the west side of Willoughby Road to half hour parking and to change some of these to seven days rather than five and a half days, as they are now.

If you are parking at Naremburn shops, make sure you check the signage or you may find that you end up with a parking fine.

Changes at Willoughby Community Pre-School

From 2015, Willoughby Community Pre-School will change models to fit within the Federal government guidelines for long day-care rather than operating under its current State government funding model.

Dianne Minnett, director of the Pre-School, wants to make it clear that the high-quality of care will remain unchanged. Importantly, the Pre-School will remain a not-for-profit and community-based centre.

The main changes relate to the funding and the hours of operation. From 2015, the centre will be open 48 weeks per year (with a 42-week option) and it will be open from 8:00 am to 4:00 pm rather than its current 9:00 to 3:00 pm.

The Pre-school will continue to offer a 2-day programme (Thursday, Friday), mainly to three year olds, and a 3-day programme (Monday, Tuesday, Wednesday), mainly to four year olds.

As a result of the changes, families who are eligible for the Child Care Rebate (CCR) and Child Care Benefit (CCB) will be able to claim a rebate from the federal government.

All places for 2015 have been filled. For more information about the changes or to enrol your child for future years, call 9437 4260.

Community garden – Summer 2014

Congratulations to Connor of Waters Rd, who won the lizard naming competition. The lizard's name is Louis. There is now a lovely mural of Louis on a rock in the garden.

We are in the process of gradually redoing the beds with a gravel base so that they will be self-wicking. This means that we are able to fill the bottom half with water that the plants then suck up and use. Hopefully this will stop them drying out so much. The first one to be done is the very bottom one.

For summer there should be lots of basil, eggplant, parsley and tomatoes. We generally also have lettuce all year round. The passion fruit vines that we have grown from seed are doing very well and producing quite a few big fat passion fruit. These will be able to be picked on the way past once they are ripe.

We will be expanding our tree collection with a couple of dwarf varieties that should be in early summer.

We can always use more scraps for the worm farms and compostable matter for the compost bins, so feel free to drop in your peelings, cuttings and clippings.

One sour note, however, is that we have noticed an increase in dog droppings not being picked up around the streets near our garden. If you have dogs, please be responsible and pick up after them, it is not fun to have to sort out your kid's shoes just before they get on the bus.

On a brighter note, there is usually someone working in the garden around 10:00am on Sunday mornings, so please drop in and say hello and have a look around. We look forward to seeing you.

What's the latest with Channel 9?

On 23 September the Land and Environment (L&E) Court held a conciliation conference at the Channel 9 property in Artarmon.

The conference was attended by Channel 9, the Planning Assessment Commission (PAC) and Willoughby City Council and their legal representatives. At this conference six members of the community addressed the L&E Court Commissioner to represent the community's view of the Channel 9 proposal.

The conciliation conference was adjourned after an initial exchange of views and information by all the parties and the continuation is scheduled for 12 December. The conference will be restricted to the three parties and members of the community will not be able attend. If the parties cannot reach an agreement the matter will be referred to an L&E Court hearing and this would be presided over by a different commissioner to the one who conducted the conciliation conference. At this stage we can only hope that there will be a favourable outcome from the conciliation conference.

Update from Cr Sloane

Fit for the Future – an opportunity not an end in itself

Change is afoot in local government and we must develop a solid direction to face the challenges presented by the State Government's plan to make local government 'Fit for the Future'.

Since the mid-1980s, local government's only direct source of tax income has been property rates, which makes up only 3–4% of the total national tax collected, and only one-third of national property taxes, the other two-thirds being an integral part of State governments' revenue base (ALGA 2007). In NSW, to further complicate matters, our rates are 'pegged'. The Rate Peg is the annual rate increase, set not by councils, but by the Independent Pricing and Regulatory Tribunal (IPART).

This is a hugely inequitable situation, as we know that in terms of sound economic and fiscal management, revenue-raising or taxation powers should match expenditure responsibilities, allowing for redistribution to needy regions and individuals by the national government. Clearly for local government this is not the case. So this brings us to the case for change and the State Government's plan to make local government 'Fit for the Future'.

'Fit for the Future' comes out of a three-year Independent Local Government Review Panel: *Revitalising Local Government* led by Graham Sansom and requested by Local Government NSW (LGNSW). **The Sansom Review recommended that 105 of NSW's 152 councils consider merging and that eight councils in the far west of the state should form a Far West organisation.**

As a result, all of NSW 152 Councils are being asked to assess their current position and submit a 'Fit for the Future' proposal by 30 June 2015. This requires councils to analyse service delivery, scale of operations, financial sustainability and management of infrastructure. They must also contain details about a council's infrastructure backlog, asset maintenance, debt service ratio and its ability to meet its own operating costs, among other things. Councils must then complete a 'roadmap' of how they will achieve sustainability in the future.

Under the arrangement, any new Sydney council formed by a merger would be given a grant of \$10.5 million plus further funding up to \$12.5 million for every 50,000 residents over a threshold of 250,000. However, mergers are opposed by many in our communities.

The Minister for Local Government, Paul Toole has said that **'Councils are losing \$1 million a day and we've got boundaries that were drawn up over 100 years ago. It is clear that "no change" is not an option.'**

Change is definitely here and in my view, the best place for our community to be is 'at the table' ready to discuss options. Willoughby City Council has been a leader in arguing for and establishing shared service arrangements and seeking to identify cost savings and new revenue sources. We have shown that we can embrace change, but we need to do more.

'Fit for the Future' presents many opportunities but as we have seen in Queensland, council mergers are not an end in themselves – like any significant change, there are many factors that will either enable success or render the outcome unworkable.

The challenges for local government are real and a 'business as usual' approach will not be enough to overcome these challenges. Local government and its leadership – elected Councillors and senior management – must rethink how it functions and consider innovative ways for the provision of public services provided to support communities and improve their quality of life.

Local government is so much more than just a provider of local services. It is the tier of government that is the most accessible – the tier of government that showcases democracy in action in a much more immediate and direct way than either state or federal government. Local government is about communities. So let's embrace the changes that lie ahead and work together to craft a sustainable future for the tier of government that can and must do the heavy lifting in terms of creating and maintaining our communities of the future.
